DNP Essential V:

Health Care Policy for Advocacy in Health Care

The DNP program prepares the graduate to:

- 1. <u>Critically analyze</u> health policy ...from the perspective of <u>stakeholders</u>...
- Demonstrate leadership in the development & implementation of institutional, local, state, federal, and/or international health policy.
- 3. Influence policy makers through active participation ...to improve health care delivery and outcomes.
- 4. Educate others...regarding nursing, health policy, and patient care outcomes.
- 5. <u>Advocate</u> for the nursing profession within the policy and healthcare communities.
- 6. <u>Develop, evaluate</u>, and provide leadership for health care policy that shapes health care financing, regulation, and delivery.
- Advocate for social justice, equity, and ethical policies within all healthcare
 arenas.

Health Services Research

- "...examines the

to increase knowledge & understanding of the structure, processes & effects of health services for individuals & populations"(IOM, 1995, p. 17).



Population Health

Examine selected health policies (actual or proposed) for specific population health problems through the lens of evidence to support the policy because it is effective, efficient & equitable.

- Identify the population health problem.
- · Identify the health policy.
