Problem

Nursing shortage is complicated by nurse faculty shortage. Faculty are expected to complete doctoral degrees, incurring significant education debt and facing salary inequity in clinical vs. faculty role. Maryland had two new faculty focused programs to address new faculty education, recruitment and retention.

Background

In 2012, Maryland Deans and Directors recommended the **Nurse Educator Doctoral Grants for Practice and Dissertation Research (NEDG)** program to address the needs of existing faculty for funding to expedite doctoral completion and reduce the burden of faculty with student debt.

Program Evaluation

A program evaluation of the NEDG in 2019 demonstrates a positive impact on retention. NEDG data indicates 9 out of 10 awardees are continuing employment as faculty with a Maryland nursing program. In addition, 60% of faculty were seeking doctoral degrees out of state. Doctoral Education Summits started in 2018.

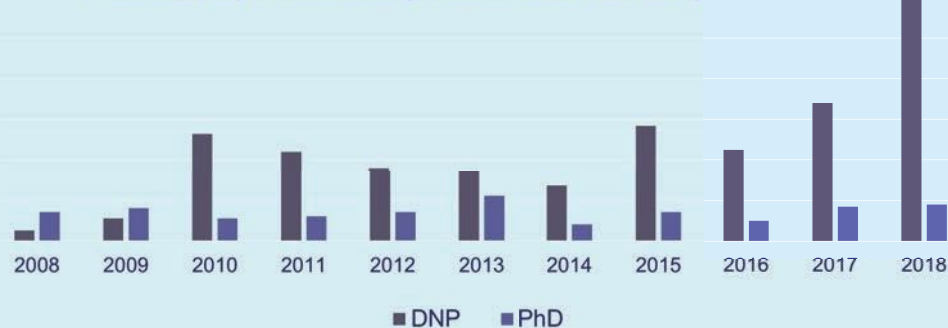

Faculty Debt Burden

In 2015, 4.5 billion defaulted student loans
 10% of students are retired, still in debt and having their Social Security garnished
 Feeg and Mancino (2014) found that nursing students are similar to other undergraduates with an average of \$30,000 in student debt
 Survey of NEDG faculty participants (2017) compared to AACN Survey (October 2017)
 AACN: 69% loans/ 27% institutional aid
 16% owed > \$100K compared to 14% NEDG

NEDG FACULTY SURVEY

22% owed \$20,000- \$49,999
 16% owed \$50,000-\$74,999
 11% owed \$75,000-\$99,999
 9% owed greater than \$100,000
 5% owed greater than \$175,000

Conclusions

The State of Maryland has funded nurse education programs since 1986 through the Nurse Support Program funded by the Health Services Cost Review Commission (HSCRC). NEDG funding is available to all Maryland nurse faculty to complete terminal degrees.
