AGACNP-AGCNS Specialty

- Clinical nurse specialist & nurse practitioner competencies where participation in professional organizations is an entry level competency
- Faculty role modeling & engagement to promote policy work
- Exposing students to the legislative process through class assignments increases familiarity, though it is unclear if it is enough to sustain momentum in public policy advocacy beyond graduation
